**OFFICE MEMORANDUM**

**Sub: Declaration of CPIO under Section 5(1) of RTI Act, 2005 for different wings of DDKs & other subordinate offices of Doordarshan - Reg.**

It is brought into the notice that some of the Head of Offices of Doordarshan Kendras have declared its officers as CPIO/APIO for different wings. The Directorate General, Doordarshan, New Delhi, is also receiving requests from other Doordarshan Kendras for declaration of CPIOs for different wings i.e. Programme, News, Engineering & Administration.

02. In this connection, it is pertinent to mention here that the Doordarshan Directorate has declared its officers as CPIOs/FAAs **designation-wise** for providing reasonable assistance to the persons requesting for information under RTI Act, 2005.

03. Since it is an obligation on the part of a public authority to designate as many officers as CPIO under Section 5(1) of RTI Act 2005, therefore, the requests received from the Doordarshan Kendras for declaration of the CPIOs for different wings alongwith the list of Officers already declared as CPIO by the other Doordarshan Kendras were placed before the Competent Authority, DG:DD, for consideration. The Competent Authority, DG:DD, after perusal of the same is of the view that the subject matter may be got reviewed by constituting a Committee under the Chairmanship of Shri O.K. Sharma, ADG(E) & Nodal Officer (RTI) to resolve the issue.

04. Therefore, all the Head of Offices of Kendras are requested to furnish the following details to the Deputy Director (Admn.) & (RTI) within 15 days from the date of receipt of this Office Memorandum, so that the same could be placed before the Committee :

- Comments on declaration of CPIOs for different functional wings;
- List of such officers who are proposed to be declared as CPIOs alongwith other details i.e. Telephone & Mobile Numbers, e-mail IDs and offices addresses etc.
- List of already declared and functioning CPIOs alongwith other details i.e. Telephone & Mobile Numbers, e-mail IDs and offices addresses etc. (in case there is a change).

05. All the Head of the Offices are also requested to kindly visit the RTI portal of DG:DD i.e. [www.ddindia.gov.in](http://www.ddindia.gov.in) as well as their e-mails regularly to view the latest Orders/OMs/Circulars issued by the DoPT/CIC/DG:DD from time to time.
