OFFICE ORDER 18/2016

In accordance with DoPT's O.M. No. 35034/3/2008-Estt.(I) dated 19.05.2009 and on the recommendation of the Screening committee, the approval of the Director General: Doordarshan is hereby conveyed to grant of 1st, 2nd and 3rd financial upgradation under ACP/MACP scheme to 32 Film/Video Editors, who have completed 10, 20 and 30 years of regular service, as mentioned in the Annexure.

2. The MACPS envisages merely placement in the immediate next higher Grade Pay, in the hierarchy of the recommended revised pay bands and grade pay as given in Section-1, Part-A of the First Schedule of the CSS (Revised Pay) Rules, 2008. Financial up-gradation(s) under MACP Scheme shall be purely personal to the employees and shall have no relevance to his/her seniority position.


3. The pay of the officials will be fixed as per the provisions of Para 4, 6.1 & 7 of Annexure to DoPT's O.M. dated 19.05.2009. Before fixation of pay, the date of appointment may be verified.

4. Heads of all Doordarshan Kendras are requested to recheck the service particulars/ penalty statement and vigilance clearance in respect of the listed officials scrupulously and in case of any doubt refer the matter to Directorate General for clarification before the pay fixation. Heads of all Doordarshan Kendras are also requested to ensure that the financial upgradation granted hereunder, has already not been granted to the incumbents listed in the Annexure.

5. The above pay fixation is subject to post-audit and in the light of audit observation and further clarification from Prasar Bharati, Ministry of I&B and DoPT, inadvertent administrative and clerical mistake, typographical error etc., over-payment, if any, shall be recovered from them in lump-sum.

6. This issues with approval of Director General.
