

Quotation will be opened on 19.08.2016 at 3.00pm in the presence of tenderers or their authorized representatives who may like to present at the time of opening of quotation. Authorization letter is required for entering in the premises.

The bid of highest bidder will be accepted and allowed to remove all the auctioned material within 3 days from the date of finalization of tender after depositing total amount in advance calculated after weighing.

1. Every bidder will be required to deposit earnest money of Rs.1000/- in the form of Bank Draft in favour of DDO, CPC: Doordarshan payable at New Delhi from any nationalized bank, which will be refunded on closing of the bid.
