References and phone calls received from various officials and DDKs for
Granting 1st/2nd/3rd financial up-gradation under MACP scheme.

2. As per (1) MACP scheme followed by Prasar Bharati, (2) M/o I&B order
No.310/173/97-B(D) dated 25.02.1999, (3) Clarification issued vide DoPT's I.D.
No.47539/13/CR dated 10.07.2013 and (4) Ministry's letter dated 503/5/2014-
BA(E) dated 08.09.2014, following Production Assistants/PEXs(In-situ) are
eligible for Granting 1st/2nd/3rd financial up-gradation under MACP scheme:-

- (i) Eligibility for the 1st MACP : Officials who have completed 10 years of regular service in the grade of Production Assistants and drawing Grade Pay Rs.4200/- till 31.12.2015.
- (ii) Eligibility for the 2nd MACP : Only those Production Assistants/PEX(In-situ) will be eligible who have not given the benefit of upgraded scale either through the M/oI&B's Order dated 25.02.99 or through Court and who have either completed 20 years of regular service in the grade of Production Assistants or drawing Grade Pay Rs.4600/- till 31.12.2015 in lieu of 1st MACP since last 10 years, whichever is earlier.
- (iii) Eligibility for the 3rd MACP : Who have either completed 30 years of regular service in the grade of Production Assistants/PEX(In-situ) or drawing Grade Pay Rs.4800/- till 31.12.2015 since last 10 years whichever is earlier.

3. All Doordarshan Kendras are, therefore, requested to furnish the following information/documents in respect of those Production Assistants/PEXs(In-situ) who have fulfilled the above mentioned criteria, to this Directorate immediately:-

- (i) Name of official, date of regular appointment as Production Assistant, drawn Grade Pay till 31.12.2015 and date of granting 1st/2nd MACP if any .
- (ii) Service Certificate verified from Service Book.
- (iii) Vigilance clearance/ Integrity Certificate.
- (iv) Details of major/minor penalty imposed during the last 10 years, if any.

- (v) Certified copy of APARs for preceding five years from the date since MACP is due. No Report Certificate, if APAR of any period is not available.
 - (vi) Details of break-in-service/dies-non, if any.
