OFFICE MEMORANDUM

The Prasar Bharati Secretariat, New Delhi in its communication No.N-10/7/2013-PPC dated 01.04.2016 to this Directorate has clarified that the Post of Cameraman, Grade-I is promotional post for the lower post and not direct recruitment entry grade of Group-A and they be placed in PB-2 with Grade Pay Rs. 5400/-.

2. It has been further clarified that as per 6<sup>th</sup> CPC, pre-revised Pay Scale of Rs. 8000-13500 (Group-A) was bifurcated into two grades viz PB-3 and PB-2 with grade pay Rs. 5400/-. The post which were promotional posts were put in PB-2 with Grade Pay Rs. 5400/- and those posts which were direct recruitment entry grade for Group -A were put in PB-3 with Grade pay of Rs. 5400/-.

3. As such, this Directorate's order No. 33/4/2011/S.I (A) dated 12.01.2012 issued in regard to the Pay Scale of Cameraman, Grade-I of DG:DD is **hereby withdrawn with retrospective effect.**

4. Further, the Pay Scale in r/o Cameraman, Grade-I of DG: DD may be read as Rs. 9300-34800, Grade Pay of Rs. 5400/- in PB 2 for all purposes with retrospective effect.

5. The H.O.O. of all the Kendras are hereby directed to re-fix the pay of all the Cameraman Grade-I working in their Kendra in PB-2 with Grade Pay Rs. 5400/- wherever the pay has been fixed in PB-3 and effect/ make the recoveries of overdue payment, if any.

6. The replacement Scale of Rs. 15600-39100 in PB 3 Grade Pay Rs. 5400/- granted to the Cameraman Gr.-I & Grade-II at the time of granting ACPs/MACPs may also be revised keeping in view the Pay Scale of Cameraman, Grade-I as Rs. 9300-34800, Grade Pay Rs. 5400/- in PB-2.

7. It is further directed that as the benefits under the MACPS are allowed in the Grade Pay hierarchy. any up-gradation availed during their career may be counted against the three up-gradations permissible under the MACP Scheme.

8. All the H.O.O. are also suggested to forward the cases relating to grant of 3<sup>rd</sup> MACP in r/o all the eligible Video Executive (VEX), Cameraman, Grade-I & II to this Directorate immediately along with the details of ACPs /MACPs granted or to be granted in the enclosed Annexure.

9. Action with regard to paras 5 & 6 above be taken in a time bound manner and report may be sent to this Directorate immediately.

10. This issues with the approval of Competent Authority.


